Visa Advanced Authorization (VAA)

Machine learning model generates a risk real time score for each transaction by analyzing the network for emerging fraud patterns and identifying transactions that do not fit individual usage patterns for better authorization decisions.



Visa Risk Manager (VRM)

Is an intelligent decisioning rules solution that uses data collected via VisaNet to deliver unprecedented risk insights. It enables you to create customized, analytics-informed rules that deliver the optimal customer experience.



Visa Strategy Manager (VSM)

EMV 3-D Secure

Visa Consumer Authentication Service (VCAS)

Is a data driven hosted solution that works behind the scenes to evaluate each transaction based on data from Visa, the merchant, and the issuer, and eliminates the need for customer enrollment and static passwords using risk-based and dynamic authentication.



Visa Token Services (VTS)

Replaces sensitive account information, such as the 16-digit primary account number, with a unique digital identifier called a token. The token allows payments to be processed without exposing actual account details.



Visa Transaction Controls (VTC)

Let's cardholders set limits on an account's use (PAN or token) and trigger notifications (push, SMS, email) based on the purchase amount, total spending and/or type of transaction performed (e.g. e-commerce). It allows to set Alerts, Blocks, or Both based on transaction type and/or amount per transaction and/or amount total.



Cybesource Decision Manager (DM)

Decision Manager is a hosted fraud management tool that enables you to identify legitimate orders quickly and that reduces the need to manually intervene in your order review process. You can accurately identify and review potentially risky transactions while minimizing the rejection of valid orders.
